THIS TAX RATE WILL RASIE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEARS RATE. THE TAX RATE WILL EFFCTIVELY BE RAISED BY 12.37 PERCENT AND WILL RASIE TAXES FOR MAINTENACE AND OPERATIONS ON \$100,000 HOME BY APPROXIMATELY \$30.34.**
